A BILL

To amend Kristen’s Act to provide for the inclusion of information related to developmental disabilities, alzheimer’s disease, and dementia, in alerts issued through the Ashanti Alert communications network, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Enhanced Alerts for
5 Missing Loved Ones with Disabilities Act of 2026”.

1 **SEC. 2. ALERTS FOR MISSING ADULTS WITH DEVELOP-**
2 **MENTAL DISABILITIES, ALZHEIMER'S DIS-**
3 **EASE, AND DEMENTIA.**

4 Section 204(b) of Kristen's Act (34 U.S.C. 21904(b))
5 is amended—

6 (1) in paragraph (1), by inserting after “(in-
7 cluding health care needs” the following: “and
8 whether the individual has a developmental disability
9 (as such term is defined in section 102 of the Devel-
10 opmental Disabilities Assistance and Bill of Rights
11 Act of 2000 (42 U.S.C. 15002), alzheimer's disease,
12 or dementia”;

13 (2) in paragraph (3), by striking “suffers from
14 a proven mental or physical disability” and inserting
15 the following: “has been diagnosed with a mental
16 disability, a physical disability, a developmental dis-
17 ability, alzheimer's disease, or dementia”.

18 **SEC. 3. TRAINING RELATED TO DEVELOPMENTALLY DIS-**
19 **ABLED MISSING PERSONS.**

20 (a) **MISSING ADULTS.**—Section 206 of Kristen's Act
21 (34 U.S.C. 21906) is amended—

22 (1) in paragraph (1), by striking “and” at the
23 end;

24 (2) in paragraph (2), by striking the period at
25 the end and inserting “; and”;

26 (3) by adding at the end the following:

1 “(3) training and educational programs related
2 to responding effectively to a reported missing adult
3 with a developmental disability.”.

4 (b) MISSING CHILDREN.—Section 301(b) of the
5 PROTECT Act (34 U.S.C. 20501(b)) is amended—

6 (1) in paragraph (3), by striking “and” at the
7 end;

8 (2) in paragraph (4), by striking the period at
9 the end and inserting “; and”; and

10 (3) by adding at the end the following:

11 “(5) provide training and educational programs
12 for use by States, territories of the United States,
13 and tribal governments, related to responding effec-
14 tively to a reported missing child with a develop-
15 mental disability.”.
